It is IVFLOW's policy to respect your privacy regarding any information we may collect while operating our website. This Privacy Policy applies to ivtherapy.eu (here in after, "us", "we", or "iv-flow.gr"). We respect your privacy and are committed to protecting personally identifiable information you may provide us through the Website. We have adopted this privacy policy ("Privacy Policy") to explain what information may be collected on our Website, how we use this information, and under what circumstances we may disclose the information to third parties. This Privacy Policy applies only to information we collect through the Website and does not apply to our collection of information from other sources.

This Privacy Policy, together with the Terms and conditions posted on our Website, set forth the general rules and policies governing your use of our Website. Depending on your activities when visiting our Website, you may be required to agree to additional terms and conditions.

Website Visitors

Like most website operators, iv-flow.gr collects non-personally-identifying information of the sort that web browsers and servers typically make available, such as the browser type, language preference, referring site, and the date and time of each visitor request. iv-flow.gr 's purpose in collecting non-personally identifying information is to better understand how iv-flow.gr's visitors use its website. From time to time, iv-flow.gr may release non-personally-identifying information in the aggregate, e.g., by publishing a report on trends in the usage of its website.

iv-flow.gr also collects potentially personally-identifying information like Internet Protocol (IP) addresses for logged in users and for users leaving comments on <https://iv-flow.gr> blog posts. iv-flow.gr only discloses logged in user and commenter IP addresses under the same circumstances that it uses and discloses personally-identifying information as described below.

Gathering of Personally-Identifying Information

Certain visitors to iv-flow.gr's websites choose to interact with iv-flow.gr in ways that require iv-flow.gr to gather personally-identifying information. The amount and type of information that iv-flow.gr gathers depends on the nature of the interaction. For example, we ask visitors who sign up for a blog at <https://iv-flow.gr> to provide a username and email address.

Security

Advertisements

iv-flow.gr uses Google AdWords for remarketing

iv-flow.gr uses the remarketing services to advertise on third party websites (including Google) to previous visitors to our site. Some of those employees, contractors and affiliated organizations may be located outside of your home country; by using iv-flow.gr's website, you consent to the transfer of such information to them. iv-flow.gr will not rent or sell potentially personally-identifying and personally-identifying information to anyone.
